
MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is entered into this 27 DAY of AUGUST, 2022, by and between SRI SATHYA SAI SEVA ORGANISATIONS, DHULE, a non-profit spiritual organization, having its office at VAIBHAVNAGAR, JAMNAGIRI ROAD, DHULE hereinafter referred to as "the Organization", and SHRI VILE PARLE KELAVANI MANDAL'S INSTITUTE OF TECHNOLOGY, DHULE, an educational institution, having its office at SURVEY NO. 499, PLOT NO. 02, BEHIND GURUDWARA, MUMBAI AGRA NATIONAL HIGHWAY, DHULE – 424001, hereinafter referred to as "the Institute".

I. PURPOSE

The purpose of this MoU is to establish a cooperative relationship between the Organization and the Institute to promote the development of moral values, ethics, and personality development among students through workshops, seminars, and other educational activities.

II. SCOPE OF COOPERATION

The Organization and the Institute agree to collaborate in the following areas:

1. Conducting workshops and seminars on moral values, ethics, and personality development.
2. Developing curriculum materials that incorporate moral and ethical teachings.
3. Providing training for faculty members to effectively impart these teachings.
4. Any other activities mutually agreed upon.



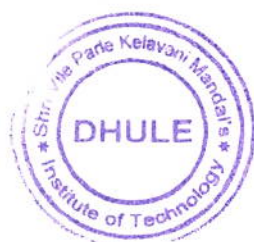
III. TERMS AND CONDITIONS

1. **Mutual Cooperation:** Both parties agree to cooperate in the development and implementation of workshops, seminars, group discussions, and other activities aimed at promoting moral values, ethics, personality development, and motivation among students.
2. **Resource Sharing:** Both parties agree to share resources and materials related to the aforementioned activities. This may include educational materials, training modules, expert personnel, and other relevant resources.
3. **Non-Misuse of Names:** Neither party shall use the name or logo of the other party in any promotional or marketing materials without the prior written consent of the other party. Any misuse of names or logos will be considered a breach of this MoU.
4. **Confidentiality:** Both parties agree to maintain confidentiality regarding any sensitive information shared between them during the course of their collaboration.
5. **Dispute Resolution:** Any disputes arising out of or in connection with this MoU shall be resolved through mutual discussion and negotiation. If a resolution cannot be reached, the parties agree to seek mediation or arbitration.
6. **Amendments:** This MoU may be amended at any time by mutual agreement of both parties. Any amendments must be in writing and signed by both parties.
7. **Termination:** Either party may terminate this MoU at any time by providing written notice to the other party.



IV. DURATION AND TERMINATION

This MoU shall be effective from the date of signing and shall continue in force until terminated by either party with written notice.
